NOTES FOR PROPOSAL FORM

Proposal Form

The Proposal Form must be completed and signed by the prospective member/representative of the family.

Only children of the prospective member who are under the age of 25 can be included in the family membership. Children over the age of 25 must apply separately for Individual Membership. Likewise upon reaching the age of 25, a child will cease to be included in the family membership and will be invited to become an Individual Member (in such instances a proposer and seconder is not required).

The Proposal Form must be signed and dated by the Proposer and Secunder who must be members and have known the prospective member for at least 2 years. The Proposer and Secunder should not be related to the prospective member or to each other. The proposer and seconder should include some brief comments in support of the application (eg the candidate's relationship with Klosters, skiing ability, length of time known, reasons for wanting to become a member etc).

The Proposal form and Bankers order once duly completed should be sent together to the Hon Secretary. Upon election members are responsible for ensuring that the Hon Secretary is notified of any changes to addresses, telephone numbers, e-mail addresses and bank details.

Subscriptions

Subscriptions which are due upon election and thereafter annually on 1st September are as follows:

- Individual Membership - £20 (or CHF 50)
- Family Membership - £50 (or CHF 125)
- Life Membership - For prospective members over the age of 18, they may compound all future annual subscriptions by a single life subscription of £500 (or CHF 1250).

Annual Subscriptions must be paid by bankers order.

A subscription will only be debited after a candidate has been elected to membership and notified of his/her election.

WARNING: If subscriptions are not paid by the due date for whatever reason, the member may be expelled from membership of the Club.
